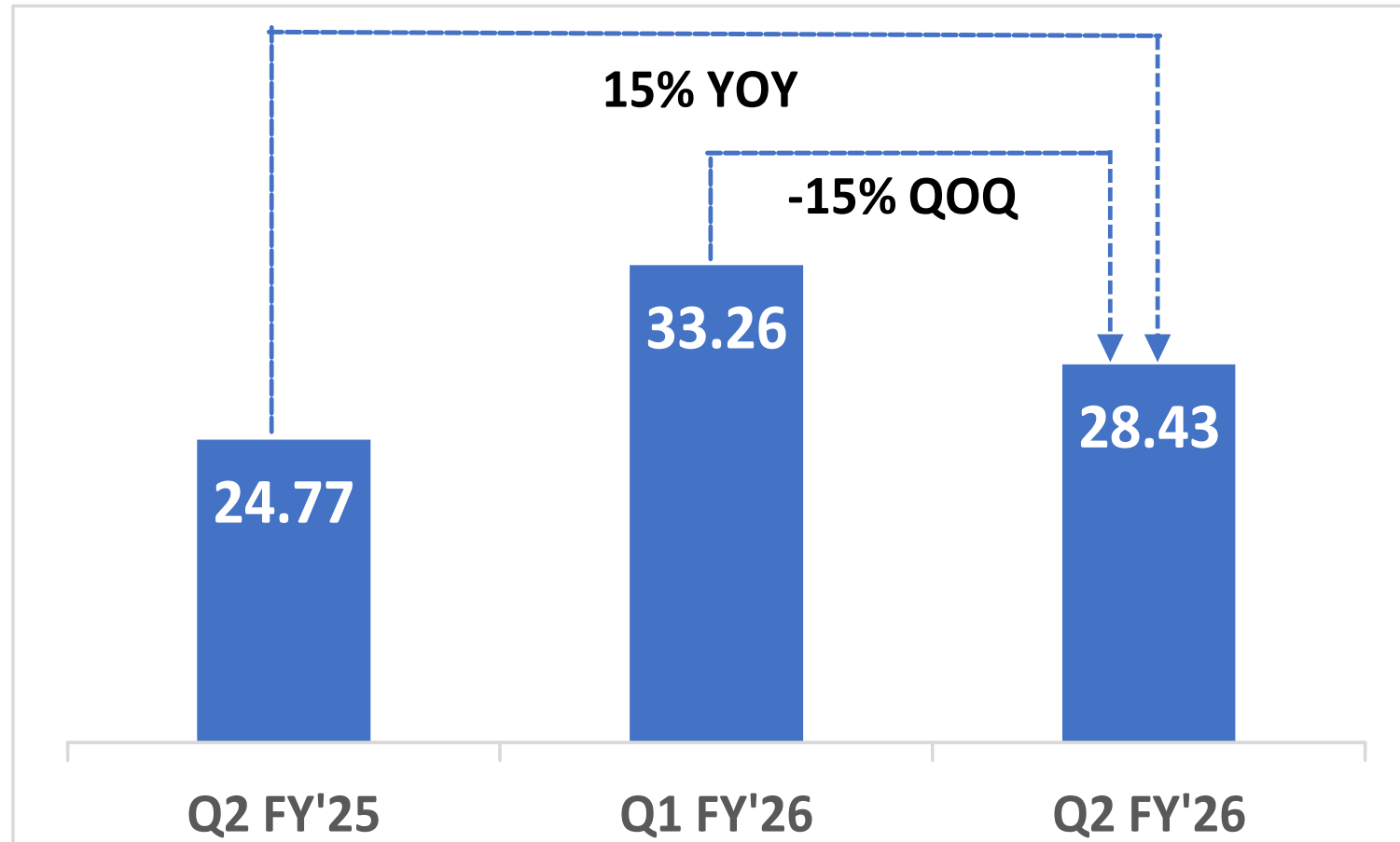

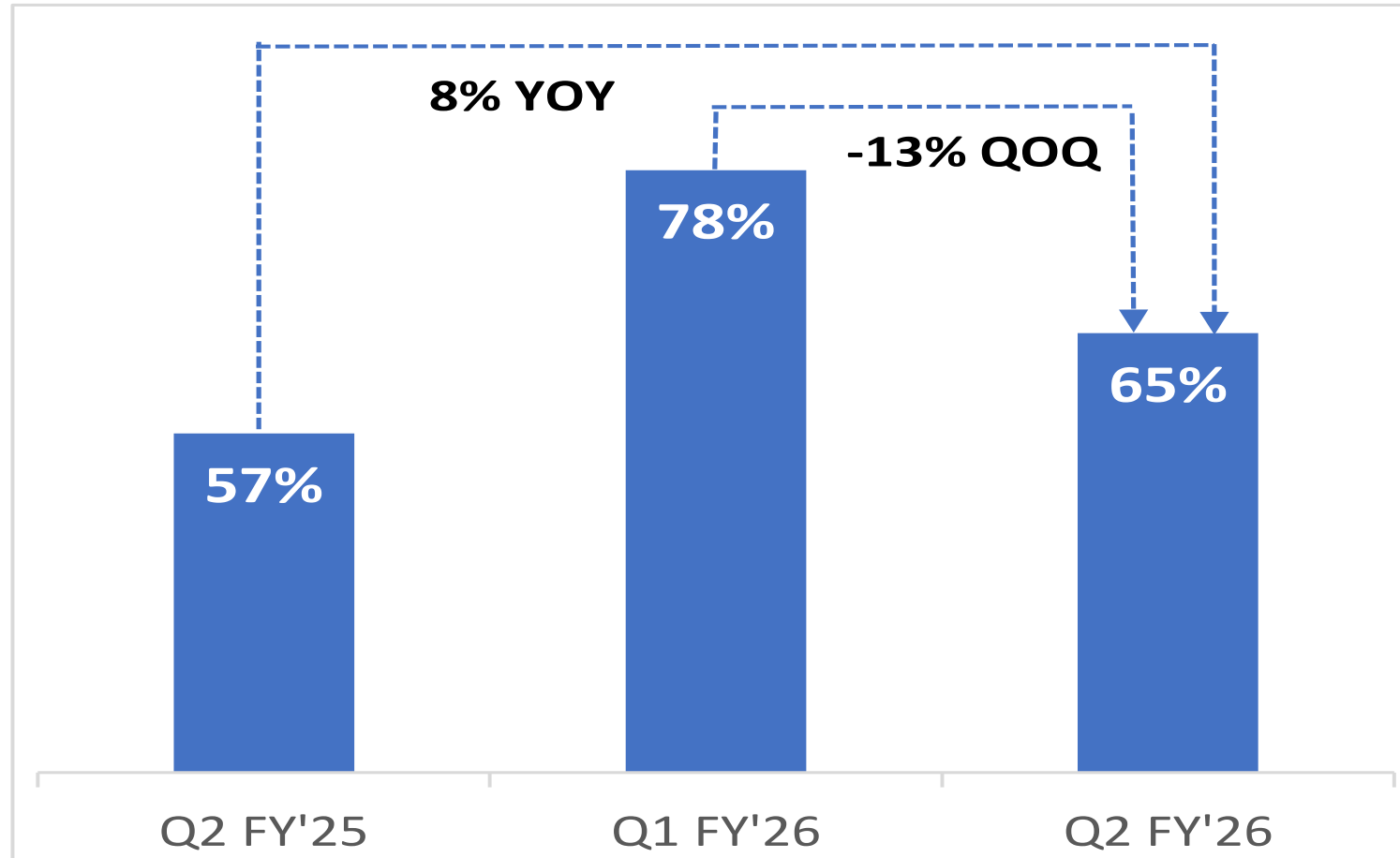
Volume Growth (Sales) - Quarterly

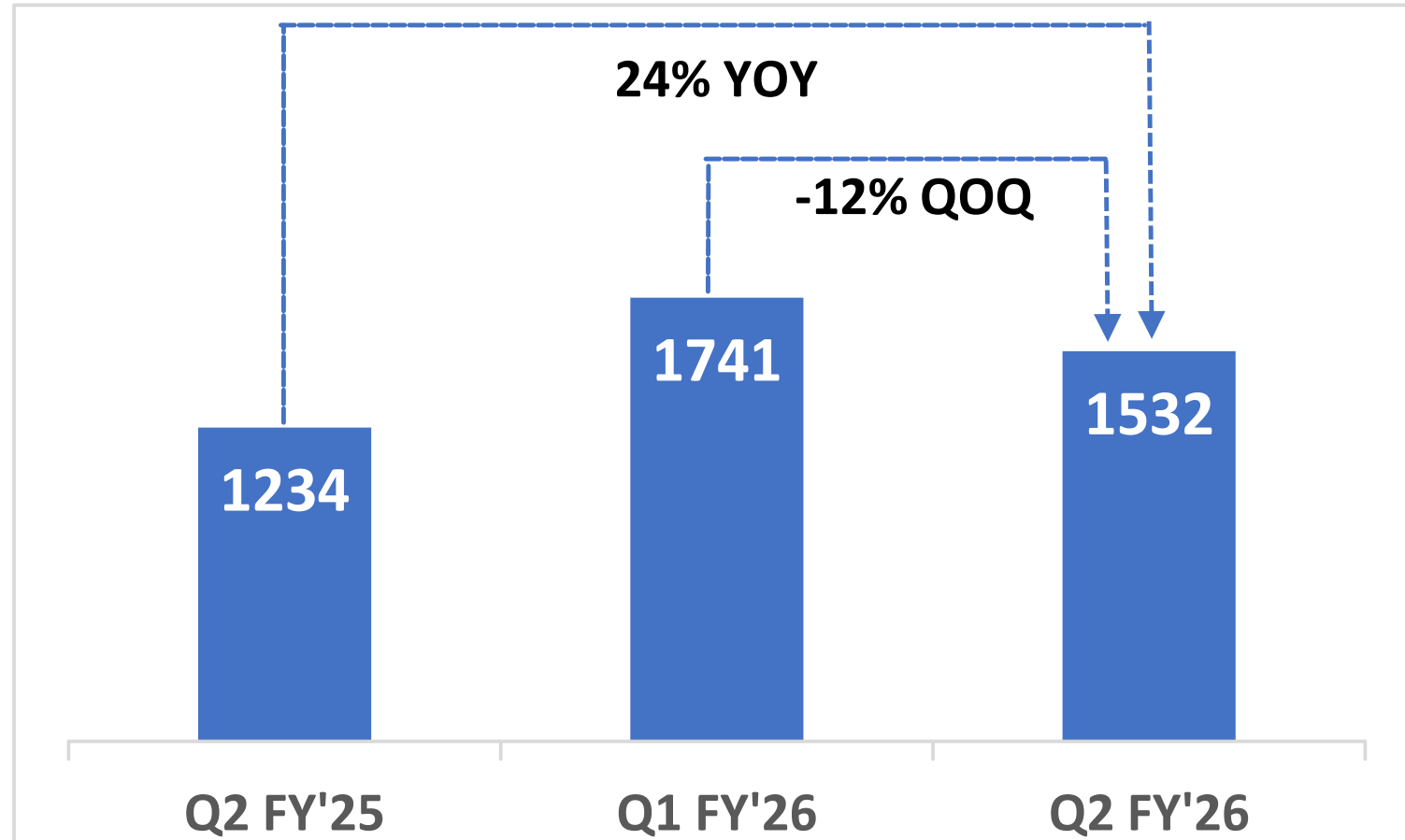
Capacity Utilisation

Total Annual Cement Capacity 18.0 MT



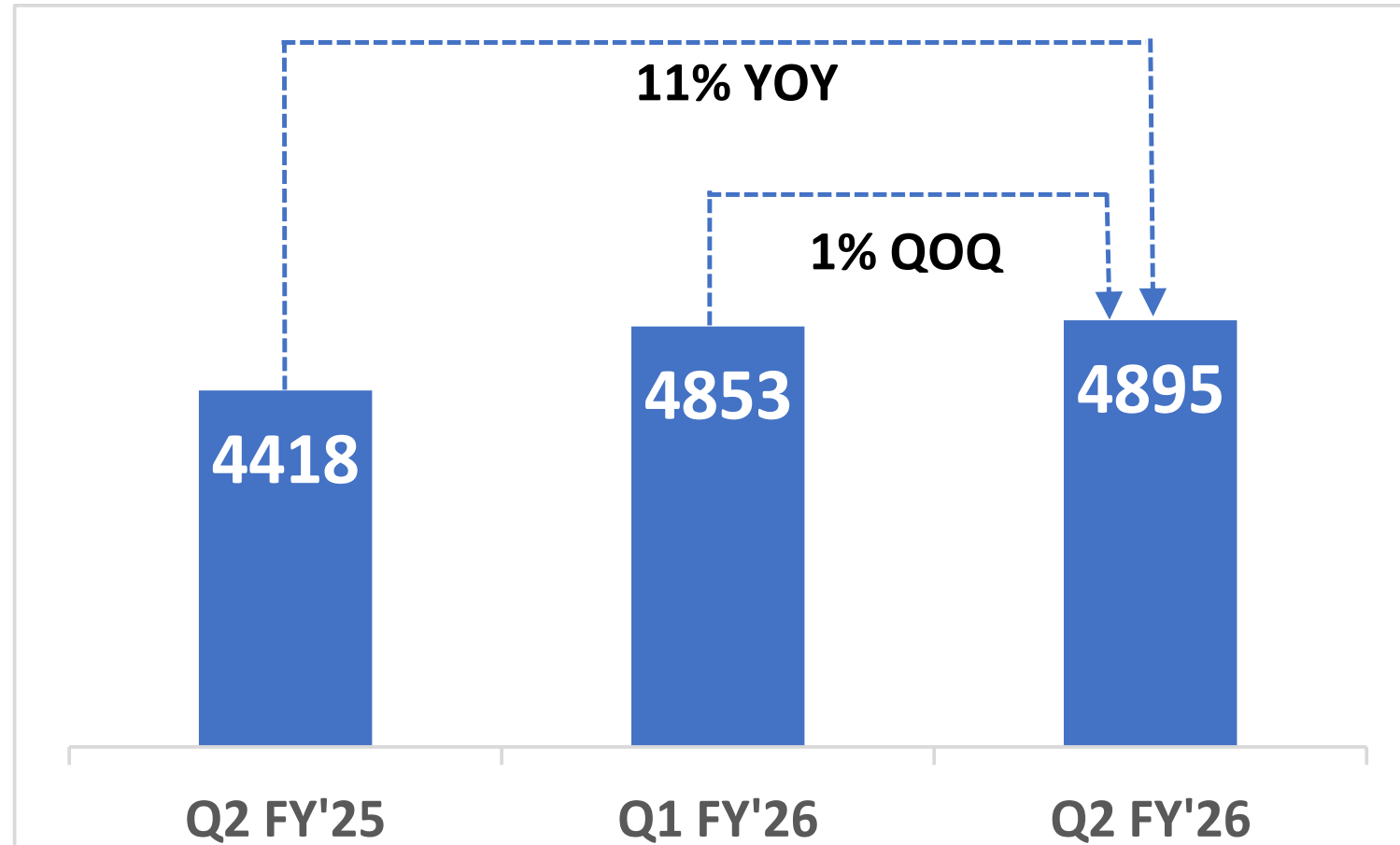

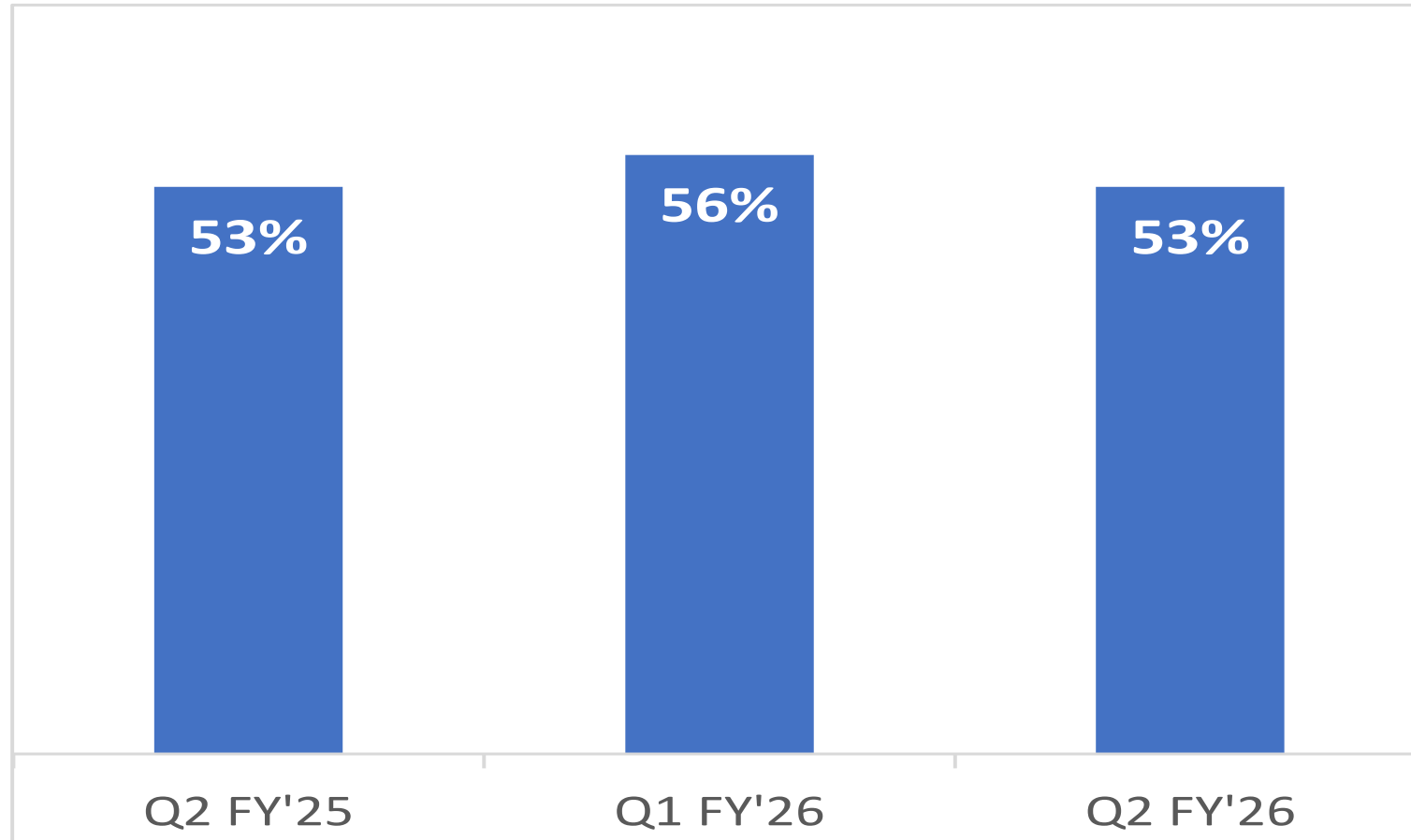


Sales Realisation - Quarterly

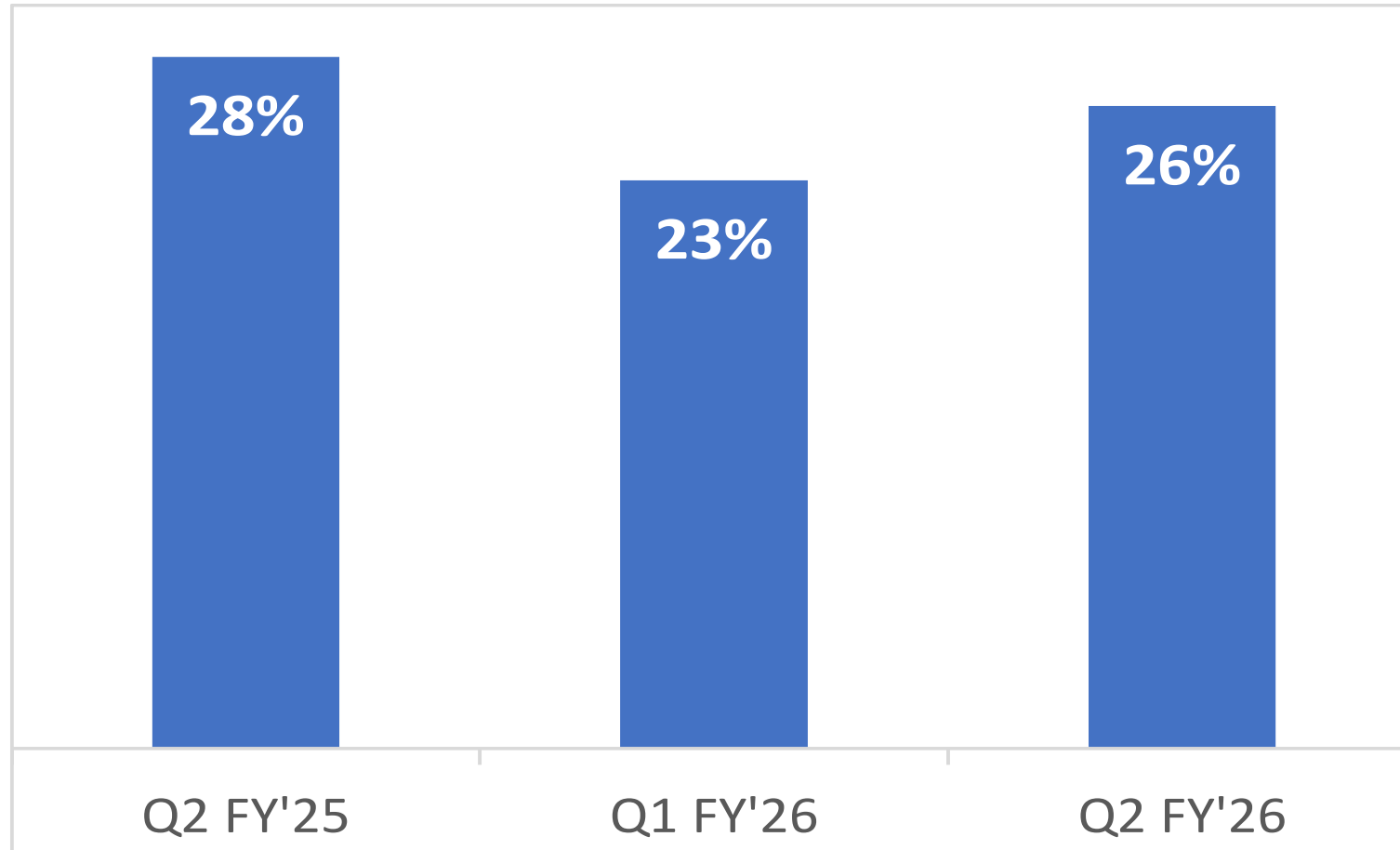

Trade Sales %

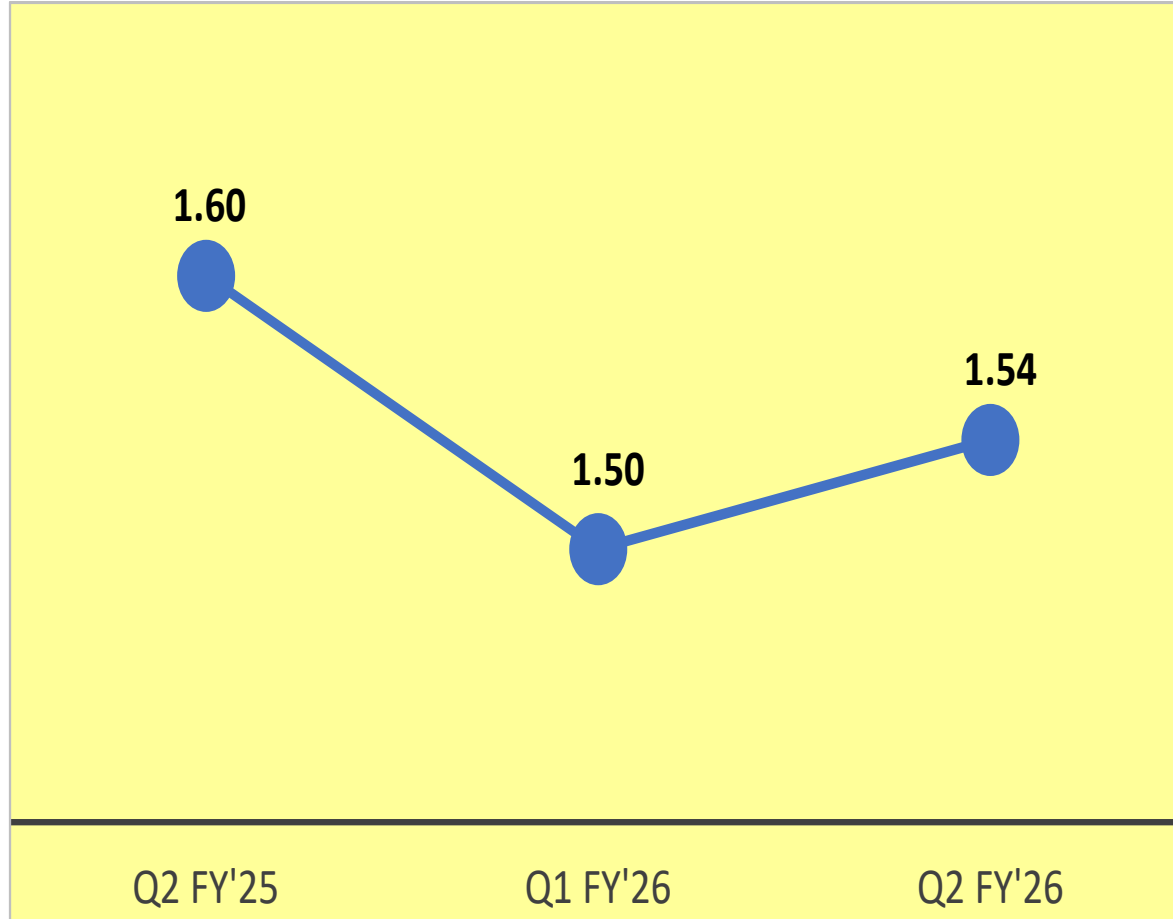


Premium Product (% of Trade Sales)

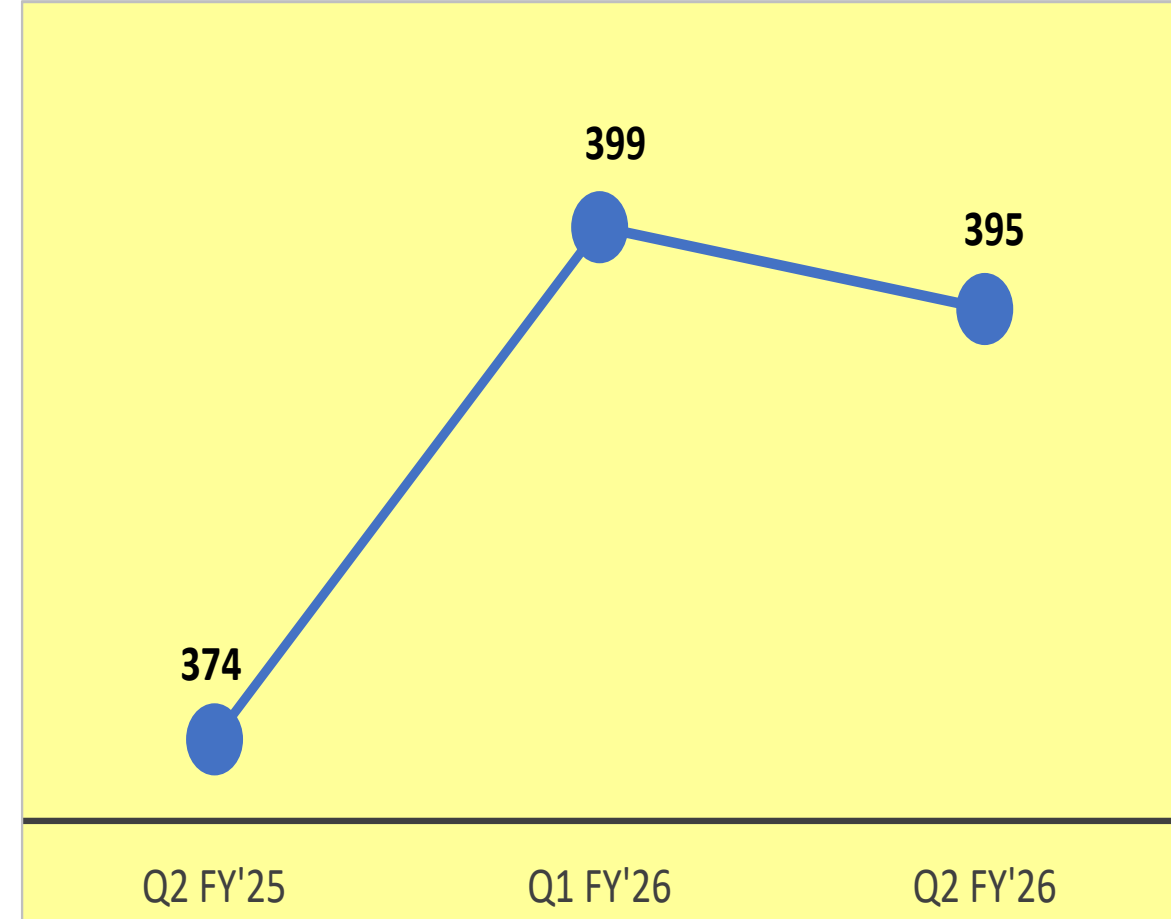


Cost Trend

Fuel Cost ₹ / K.Cal.

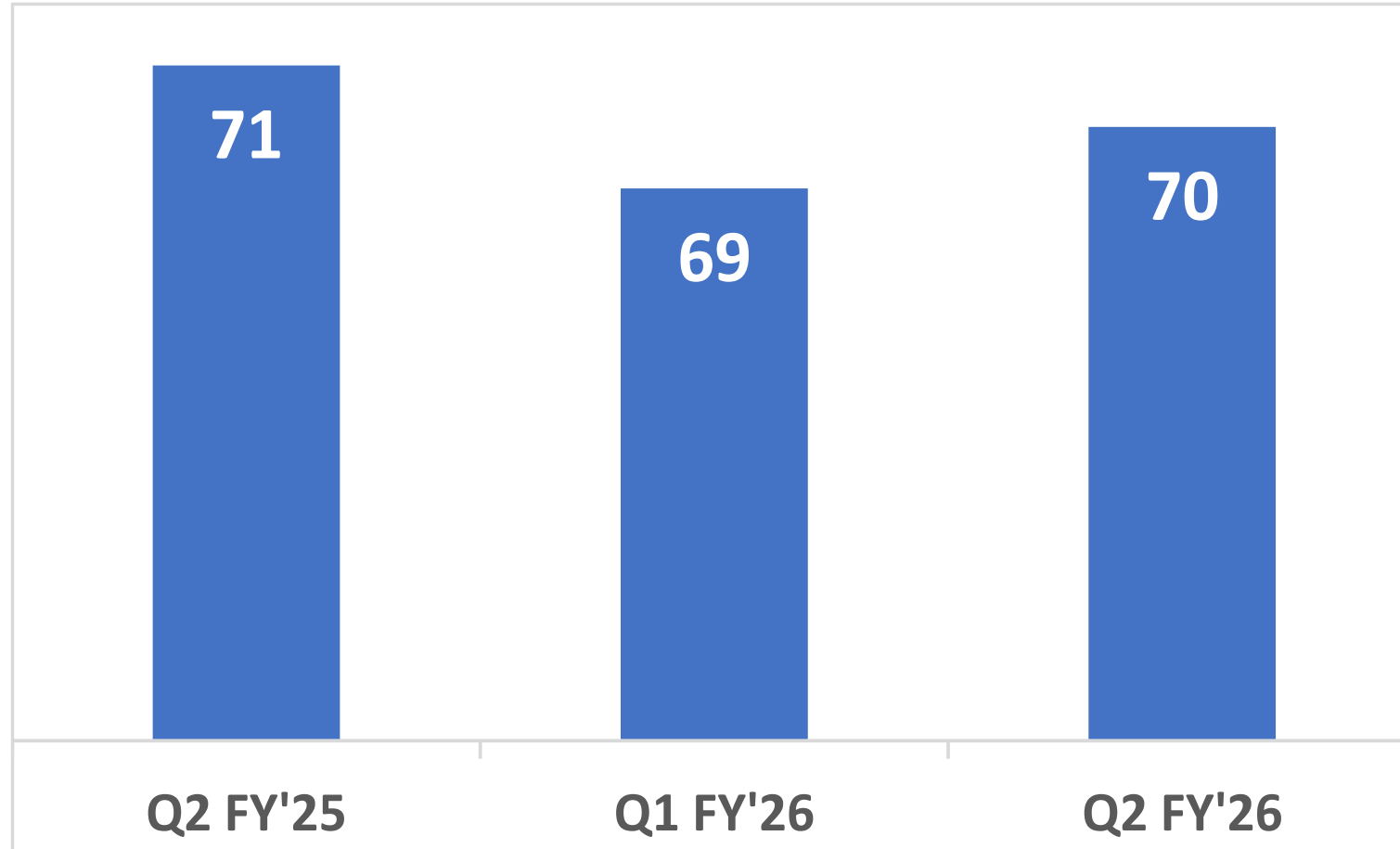


Lead Distance (Kms.)

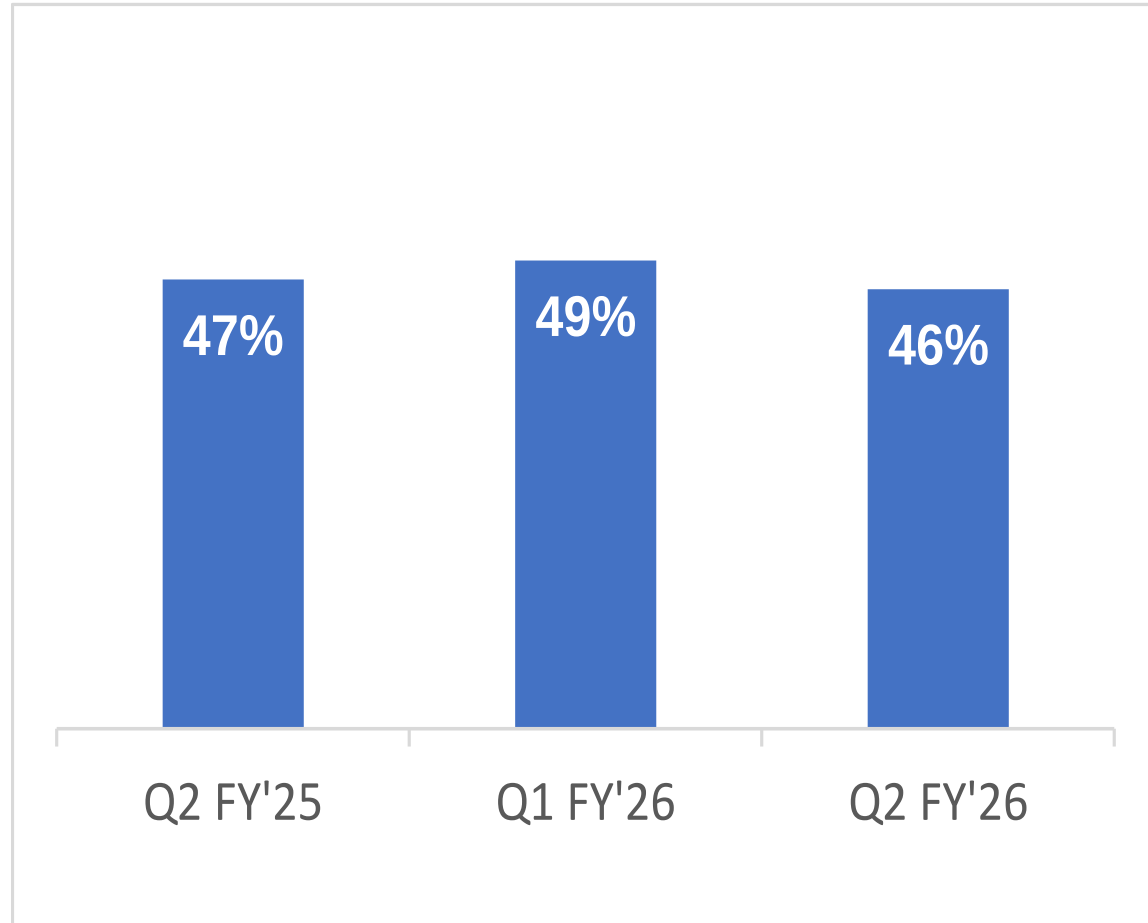


Power Consumption

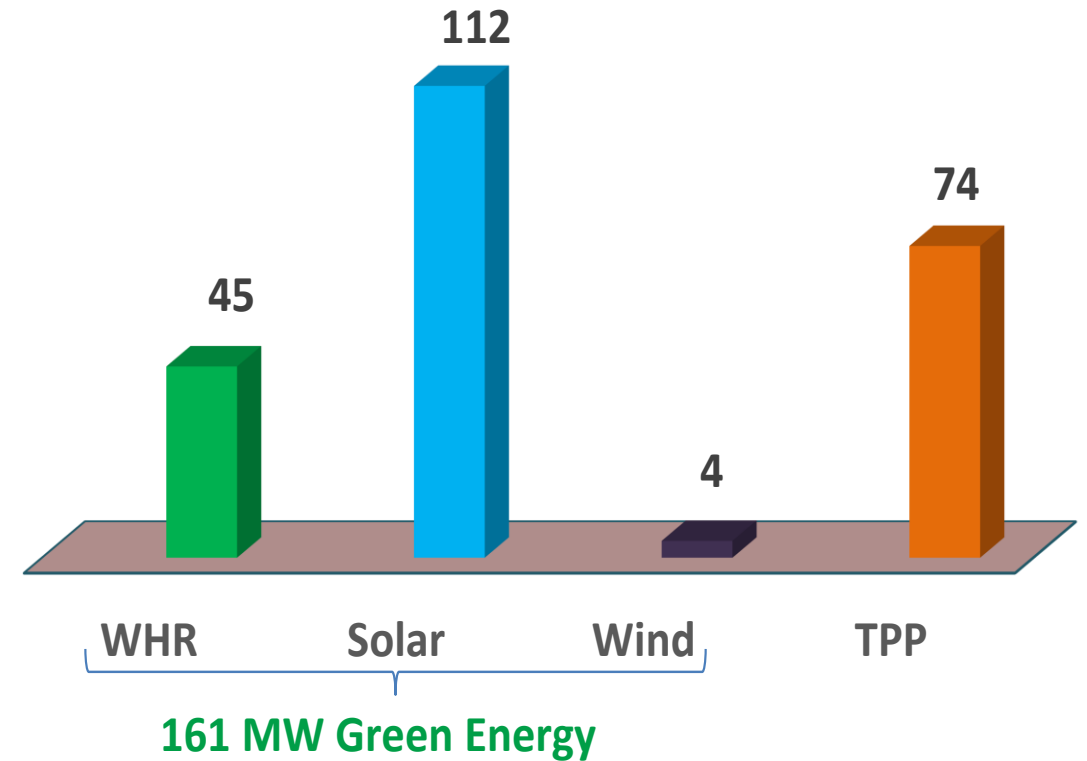
Kwh/MT of Cement

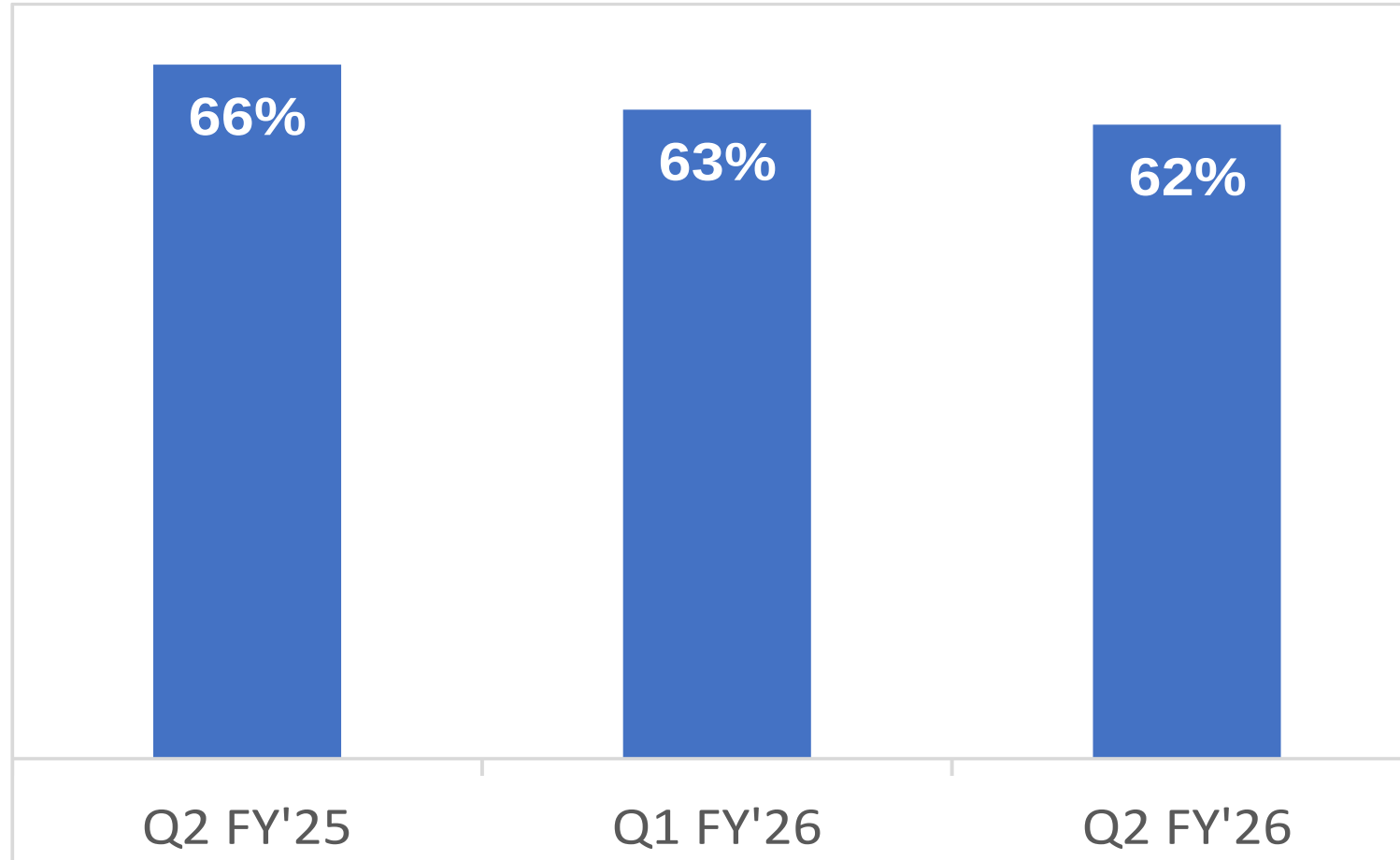

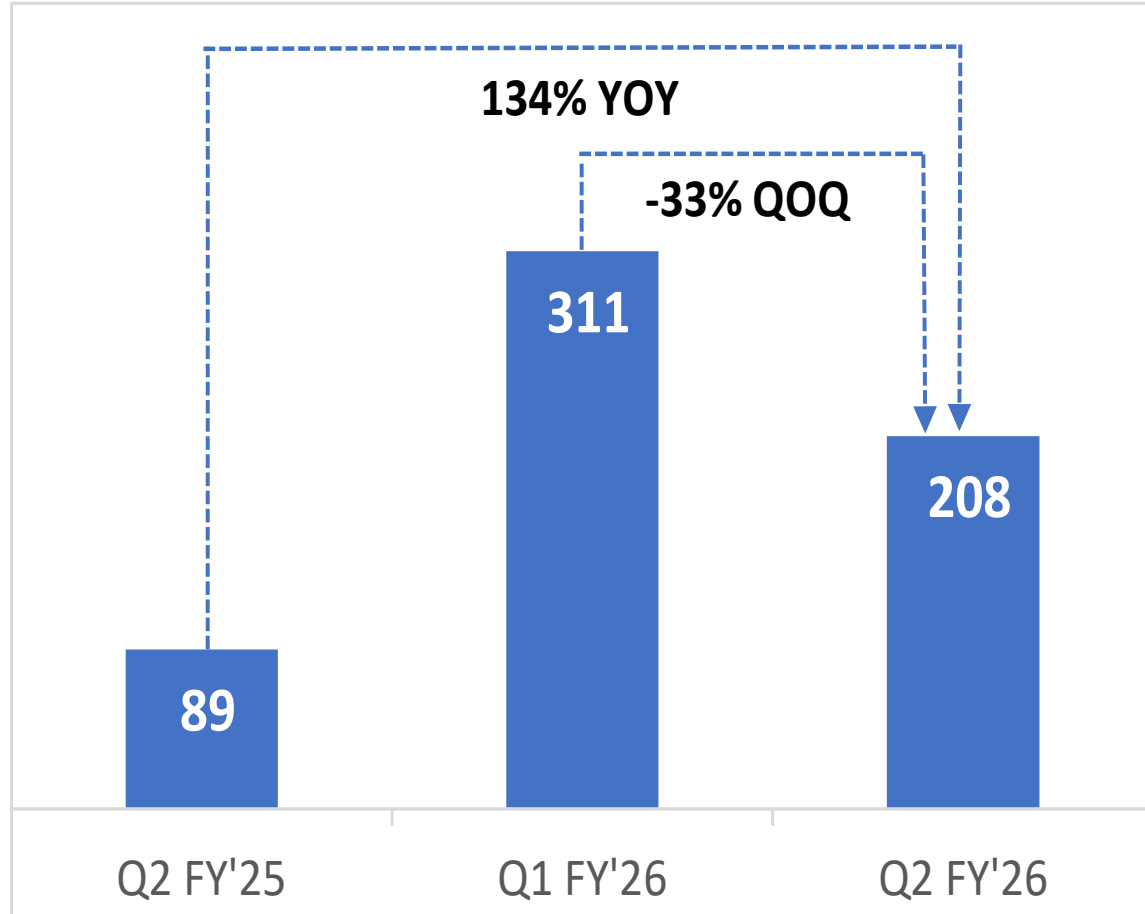

Blended Cement

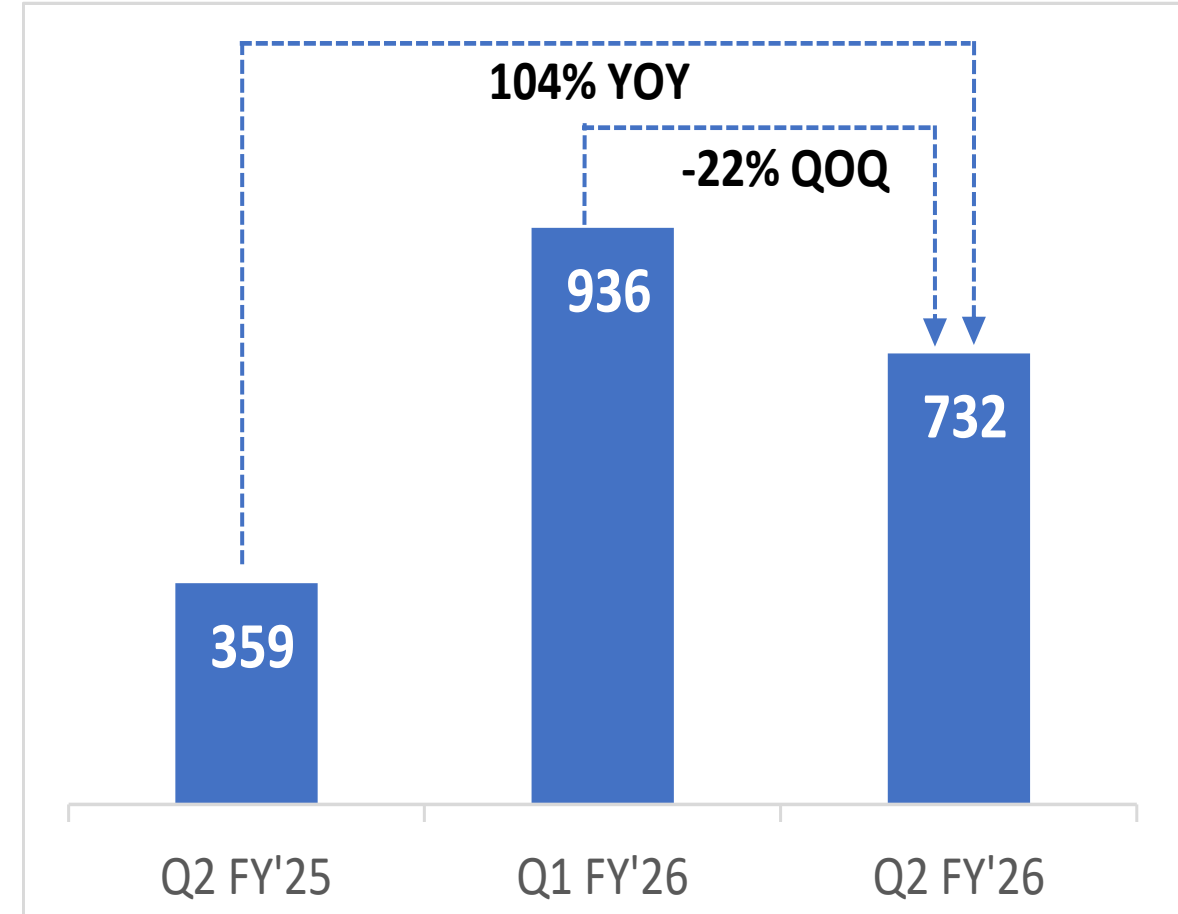

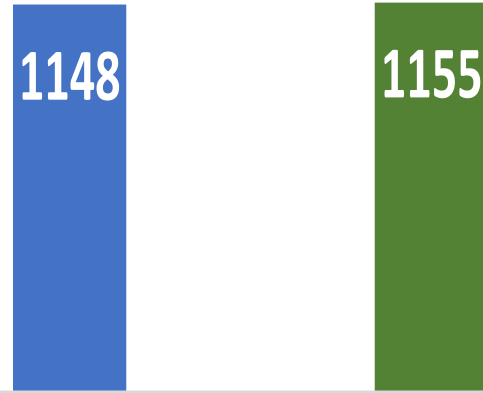

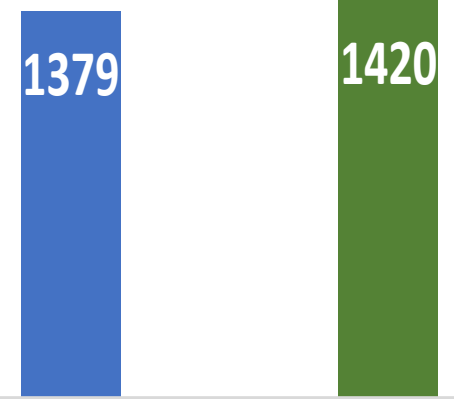

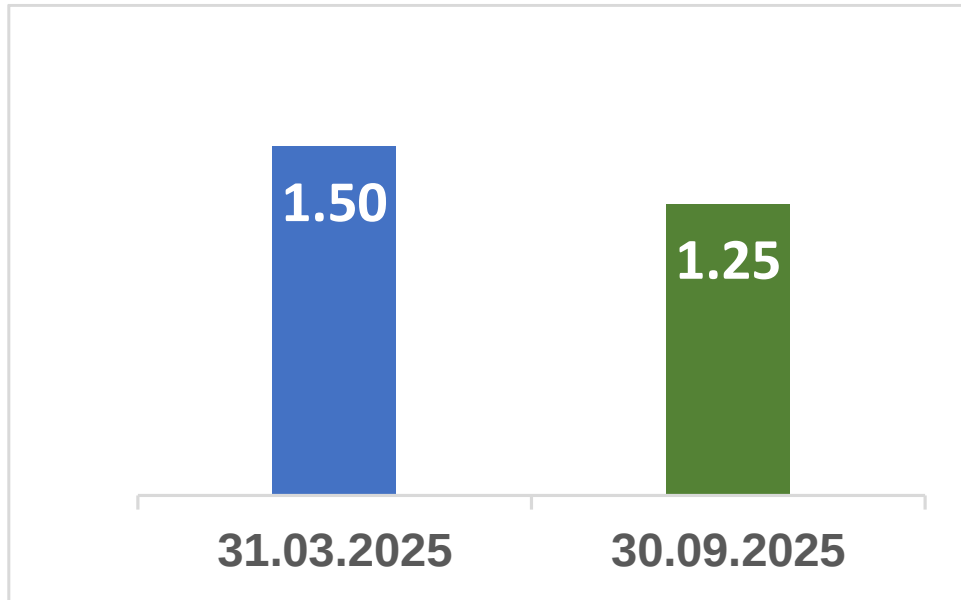

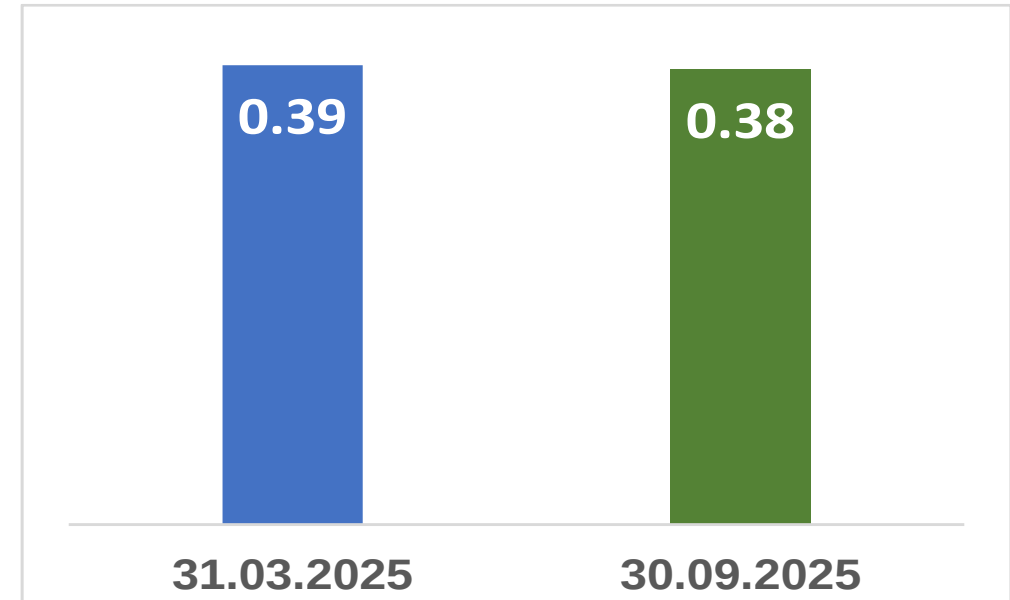
